**Save Waqf Campaign**

Road Map

**Day of Prayer (Yawm-e-Du‘ā):**

On Friday, 19th September 2025 special sermons will be delivered in mosques on the importance of waqf and the serious implications and apprehensions arising from the recently passed Waqf Amendment Act. After the sermon, the prayers will be offered for the restoration and protection of waqf properties.

**Call for a Voluntary Shutdown:**

On Friday, 3rd October, from 8:00 a.m. to 2:00 p.m., Muslims will keep their businesses, offices, and establishments closed as a mark of protest. However, medical stores will remain open.

**Protests and Arrests at Jantar Mantar and State Assemblies:**

Peaceful protests will be organized at Jantar Mantar and in front of every State Assembly. Participants will hold placards inscribed with various slogans, and behind them a large banner will display, in bullet points, the reasons for opposing the Waqf Amendment Act 2025 (in English, Hindi, and Urdu). At Jantar Mantar, the central leadership of the Board will lead the protest, while state-level protests will be organized by the respective state conveners. Members of the Board, heads of affiliated organizations, and regional leaders will also join. The Delhi protest will take place on 11th October, lasting at least two hours, followed by voluntary arrests.

## **Preparation and Publication of Booklets:**

A comprehensive booklet titled We Do Not Accept the Waqf Amendment Act will be prepared in Urdu, Hindi, and English, and subsequently translated into every regional language. The central office will publish the Urdu, Hindi, and English editions, while regional conveners will take responsibility for publication in local languages.

## **Press Conferences:**

In Delhi and in every state capital, two types of press conferences will be held: one solely comprising Board members, and another joint press conference where representatives of other minority groups and civil society leaders will also participate.

## **Round-Table Meetings:**

During this phase, large-scale round-table meetings will be organized with compatriots across the country. Efforts will be made to hold such meetings in every major city of each state. Distinguished non-Muslim personalities, political leaders, civil society representatives, and minority leaders will be invited.

## **Interfaith Meetings:**

Joint gatherings will be arranged with religious leaders of different faiths to deliberate upon the shared responsibility of protecting religious endowments and institutions across all communities.

## **Articles in Newspapers and Journals:**

Thought-provoking articles on Why We Reject the Waqf Amendment Act will be published in Urdu, Hindi, English, and regional newspapers. In addition, large numbers of letters to the editor will be sent and published, and, wherever possible, full-page advertisements will be issued.

## **Social Media Campaigns:**

1. A 15-minute video clip will be uploaded every week on YouTube, Facebook, Instagram, and Telegram. These clips will feature speeches by the Board's central office bearers, leaders of organizations, and the Board's regional conveners. Efforts will be made to include speeches of regional leaders of Muslim organizations in Bengali, Gujarati, Telugu, Punjabi, Kannada, Malayalam, and Tamil as well. These clips will be professionally produced.

2. In resistance to this black law, every conference, protest, sit-in, and march shall be broadcast live through the official channels of the All India Muslim Personal Law Board. It will be the duty of the State Conveners to ensure that this resolve is translated into action with full force and determination.

### **Campaign on “X”:**

Every fortnight, a hashtag campaign will be launched on X (formerly Twitter), with wide publicity to ensure trending visibility.

### **Mass Protest at Ramlila Maidan, Delhi:**

On 16 November, a massive protest gathering will be organized at Delhi’s Ramlila Maidan, with the participation of hundreds of thousands from across the country. Special invitations will also be extended to compatriots from other communities. The roster of speakers will include senior Muslim leaders, political representatives, civil society members, and minority leaders.

### **Waqf March:**

A peaceful march of 3–5 kilometers will be organized on separate dates in Delhi and state capitals. In Delhi, the march will proceed towards Rashtrapati Bhavan, while in the states, it will conclude at the Governor’s House. Participants will carry placards, with a prominent banner leading the march. Only dignified and pre-approved slogans will be chanted. At the end of each march, a memorandum will be submitted to the President or the Governors.

### **Memorandum to Chief Ministers:**

On 16 October, delegations comprising the members of All India Muslim Personal Law Board and leaders of Muslim organizations, under the leadership of state conveners, will meet respective Chief Ministers to present memorandum.

### **Letters to Mutawallis of Waqf:**

The President of the Board will issue a formal letter addressed to all mutawallis of waqf properties and chairpersons of state waqf boards. Members of the Board and Muslim organizations’ leaders will ensure the delivery of these letters to every mutawalli in their respective cities and regions.

## Verification of Documents:

From 1 November to 8 November, a vigorous campaign will be launched for the correction and verification of documents of all waqf properties. State conveners will prepare teams of youth volunteers in every city, including lawyers. At designated public venues, “Waqf Desks” will be set up, where mutawallis will be requested to bring their property documents for scrutiny. Those lacking proper documents will be guided by experts. Volunteer teams for this purpose will be formed in every district and state. For their training, a central workshop in Delhi will be held on 29th September, followed by training workshops for district and regional volunteers at the state level.
